## **Environmental Policy Statement**

Allgood is the UK's leading architectural ironmonger, supplying products for private commercial, public, hospitality and residential buildings in the UK and across the world. The business specifies, manufactures, sources and delivers high-quality door furniture, hardware, access control and security systems.

We recognise that we belong to an industry (construction) that is responsible for 39% of all carbon emissions in the world, with operational emissions (from energy used to heat, cool and light buildings) accounting for 28%. The remaining 11% comes from embodied carbon emissions or 'upfront' carbon that is associated with materials and construction processes throughout the whole building lifecycle.<sup>1</sup>

Being both a user of buildings and a supplier of building products we recognise our duty and indeed commercial interest to act in every way we can to improve our behaviours and products, and also to influence positively the practices of the construction sector in which we work.

The company has developed an Environmental Management System (EMS) to meet the requirements of BS EN ISO 14001 to reinforce the following commitments.

- To operate following all applicable environmental legislation and other requirements.
- To prevent pollution from the site, by ensuring that all activities carrying a risk of pollution are identified and either eliminated or controlled effectively via the adoption of appropriate control methods.
- To set objectives and targets to drive continuous improvement. The EMS will be used as a vehicle for setting, measuring, and monitoring environmental performance to ensure the success of environmental objectives, which will be reviewed on an annual basis.
